Legislative Corner

As many of you have probably read or heard in the news, the Presidential Advisory Commission on Election Integrity has requested data on all voters in the State's voter registration database. The Maryland State Board of Elections has denied the request to provide voter registration data.

The State Administrator, Linda Lamone, responded to the Presidential Advisory Commission on Election Integrity with the following:

... Your request is prohibited under §3-506 of the Election Law Article of the Maryland Annotated Code, which governs access to Maryland voter registration lists. In addition, disclosure of some of the information encompassed by your request may be prohibited under State and/or federal law. Accordingly, I am denying your request.
