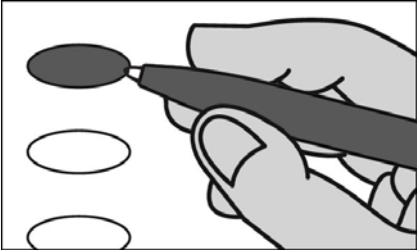

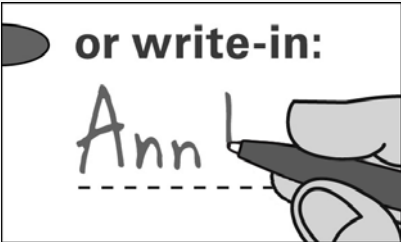

Amendment #1

This proposed amendment change is designed to curtail the submission of Constitutional and Bylaws Amendment Proposals that have repeatedly been rejected by the MAEO membership and designed to reduce the unnecessary expenditure of resources and nuisance proposals.

Amend Article XI - AMENDMENTS of the Bylaws of the Maryland Association of Election Officials 2016 as follows: In Article XI of the Bylaws of the Maryland Association of Election Officials 2016, delete the language indicated in ~~striketrough~~, and insert the language indicated in **BOLD CAPITALS**, keeping that language which is in black plain text:

The proposed Amendment would become Paragraph Numbers 1 and 5 and the current Paragraph Numbers 1 and 4 would become Paragraph Numbers 2 and 6, respectively.

ARTICLE XI – AMENDMENTS

1. IN THIS ARTICLE, THE TERM “PROPOSED AMENDMENT” MEANS ANY PROPOSAL DRAWN UP TO AMEND THE CONSTITUTION AND BYLAWS REGARDLESS OF HOW IT IS CONSTRUCTED OR DRAFTED IF THE PARTICULAR PROPOSAL HAS THE SAME OR SUBSTANTIALLY THE SAME MEANING.

5. ANY PROPOSED AMENDMENT TO THE CONSTITUTION THAT HAS BEEN DULY SUBMITTED IN ACCORDANCE WITH THIS ARTICLE FOR THE 2018 ANNUAL MEETING AND EACH ANNUAL MEETING THEREAFTER AND HAS BEEN REJECTED BY THE MEMBERSHIP BECAUSE IT DID NOT RECEIVE TWO-THIRDS OF ALL VOTES CAST, SHALL NOT BE REINTRODUCED FOR TWO SUCCESSIVE ANNUAL MEETINGS REGARDLESS OF ANY CHANGE IN LANGUAGE THAT INTENDS TO SERVE THE SAME PURPOSE.
