But it's the people that offer the greatest value to me at a MAEO Conference. To interact with my peers always lays out the possibility for new connections, new partnering, new collaborations. So, I'm here to learn and to become just a bit more adept at my job. But I'm also here to mingle, to laugh, to table-hop. I'm at the conference "to confer, converse, and otherwise hobnob with my brother (and sister) wizards."

## What's in a Name?

Congratulations! It took a couple of issues but we finally have an official newsletter name. Connect 24 Congratulations to Chrissy Sharpless, Election Supervisor from Garrett County for winning the naming contest and coming up with a clever and appropriate title; appropriate given we have 24 jurisdictions. Furthermore, within those jurisdictions lies the purpose of joining together to achieve a common goal: to improve the Election and registration in the State of Maryland; to improve the operation of the offices of the Boards of Elections throughout the State; to recommend desirable new legislation affecting voting and registration to the State Board of Elections; and to encourage fellowship and exchange ideas.

When asked on how she came up with the name, Chrissy says, "I wanted something that summarized the goal of the newsletter. I think it is a wonderful idea to keep all the members up-to-date on important issues, and I wanted to come up with a title that reflected that goal." In coming up with a name, she looked at words such as 'fusion,' 'connect,' 'united.' "As silly as it sounds," she says, "I looked at words [and] the game 'Connect 4' came to mind, and hence Connect 24 was born.

"I came up with several titles, but Connect 24 was at the top of my list. Being in 'no man's land' (Garrett County), we aren't always able to attend meetings and gatherings, and I loved the idea of a newsletter to keep us informed. I think it represents what the MAEO board was looking for; a way to unify all 24 counties."

Chrissy has submitted theme ideas for MAEO in the past. In 2014 she won for naming the theme

"Expanding our Horizons, Embracing Change." "I enjoy the challenge of coming up with ideas for these types of contests," says Sharpless.

Timing is everything, and the naming of the newsletter comes at a time where all 24 LBEs will be collaborating in an attempt to achieve those aforementioned goals at our annual MAEO conference in Ocean City.

It's time to get connected and stay connected; all 24 of us.

  Please bring your ballot to the conference or mail it in the supplied envelope to the MAEO Election Committee in the Baltimore County election office.


### **Neighbors & Partners: Cecil County**

### 2017 MAEO Conference: Business as Usual

The MAEO Conference for 2017 is underway. For many of us it's a time to reflect back on events passed, and begin preparation on how we go about preparing for the future. For the Clarion, it's business as usual.

Renee Seiden, the Director of Sales, has been working at the Clarion for 21 years. She started off as a Sales Manager before being promoted to Director. Some of her other yearly conferences include other state-wide offices such as the Maryland Office of the Public Defender, the Maryland States Attorneys Association, the Maryland State Bar Association and the Maryland Government Finance Officers Association.


