CALL TO ORDER

President David Garreis called the meeting to order at 10:06 am. Quorum was established with all nine (9) Board Members present in person. Introductions were made and roll call of those in attendance in person and by phone was recorded.

AGENDA

After a review of the Agenda, there were no additions or changes.

PRESIDENT'S REMARKS

President Garreis thanked everyone for attending the meeting and on behalf of everyone, expressed appreciation to Cindy Remmey and the Harford County election office for hosting and providing refreshments. Pizza will be served directly after the meeting and all are invited. Mr. Garreis also expressed his appreciation to his fellow MAEO members and everyone for the kind words, gifts, thoughts and prayers during his recovery.

MINUTES

The Board reviewed the Minutes from the June 17, 2019 meeting. There were no changes or additions.

MOTION: Danna Archie-Williams motioned to approve the Minutes from the June 17, 2019

Meeting.

SECOND: Armstead Jones

ACTION: Favorable and unanimous, Motion carried.

TREASURER'S REPORT

Treasurer Danna Archie-Williams provided a summary of the written Treasurer's Report. A copy was included in the Board folders and is attached to and made part of these Minutes. For the Period May 2, 2019 to October 29, 2019, receivables in the amount of \$10,711.50 were collected, and there were Expenditures in the amount of \$87,833.81 which included the 2019 annual meeting and conference master hotel bill expense. The total account balance of \$38,626.45 includes \$7,354.52 earmarked for the Educational Grants fund and \$15,000.00 earmarked for the 2020 Conference fund. The Balance on Hand as of October 29, 2019 is \$16,271.93.

MOTION: Kimberly Phillips motioned to accept the Treasurer's Report for period ending

October 29, 2019 as submitted SECOND: Alisha Alexander

ACTION: Favorable and unanimous, Motion carried.

COMMITTEE REPORTS

Verbal committee reports were provided. Alisha Alexander presented the updated Bylaws with amendments approved by the Membership at the 2019 Annual Meeting.

MOTION: Alisha Alexander motioned to adopt the amended Bylaws as approved by a majority of the Membership at the 2019 Annual Meeting.

SECOND: Danna Archie-Williams

ACTION: Favorable and unanimous, Motion carried.

The Board signed the Bylaws and Ruie Lavoie will distribute to the Membership and post to the MAEO website.

Daneen Banks sent a written update outlining the latest progress made by the Election Judge and Early Voting Committee. She submitted a letter to State Board and asked the Board to review and approve. The letter explained the work the committee has been doing with the online library. The Board unanimously approved sending the letter to the State Board.

MOTION: Armstead Jones announced that the Education and Grants Committee will be meeting directly after this meeting is adjourned.

Barry Jackson and Tiffany Ferrell provided an update for the Absentee Committee and advised that more information will follow. The committee plans to meet in the near future. Ms. Ferrell recommended that the Board appoint Rita Walczyk Evans as Co-chair of this committee. The Board unanimously agreed with the recommendation and President Garreis officially appointed her Co-chair

Kimberly Phillips reported that the Voter Regulation Committee will hold a meeting in the next few months.

Ruie Lavoie provided an update regarding the meeting with the State Board and explained that the goal of an across the board increase has changed. The new goal is to ask State Board to remove the hold on the new election series classifications and allow directors to reclassify according to their current job duties and responsibilities. In accordance with the Department of Budget and Management policy, when employees are moved to new classifications, the increase is approximately 6%. SBE agreed to the new goal and asked that each director complete a spreadsheet outlining each employee's current classification and the new classification, keeping in mind that any increase should be approximately 6%. SBE will review the submissions and if approved, the request to remove the hold on the new classifications, to be effective July 1, 2020 (FY2021) can be taken to the State Board at their December meeting for their review and approval. Should directors have any questions regarding the requested spreadsheet or new classifications, they are encouraged to contact Human Resources. It is hoped that another update and good news will be available at the December MAEO meeting.

OLD BUSINESS

2020 MAEO Annual Meeting and Conference

All theme submissions were emailed directly to Karen Perry (Cecil County). Ms. Perry provided the Board with the list of submissions leaving off the person who sent the submission. A copy of the submission list is attached and made part of these minutes. After Board review and discussion, the Board unanimously selected "MAEO: Vision of Excellence" as the theme. The Awards Committee Chair will announce the winner during the Annual Meeting. The winner will have their conference registration paid by MAEO.

2020 Annual Meeting and Conference

The Conference Committee has been working hard to finalize details of the conference such the agendas, food and entertainment. Ruie Lavoie provided a summary and explained that she is attempting to maintain the total conference cost (hotel and registration) with hopes that Directors will be able to send as many staff as possible. There will be a 50/50 raffle to benefit the Education and Grants Committee. Ms. Lavoie requested suggestions, ideas or recommendations for conference sessions, speakers, entertainment and/or anything else conference related to be sent to her by email as soon as possible.

The vendor packet was updated and revised. The Board reviewed the new packet. The Board unanimously approved the packet as submitted. The committee will start reaching out to vendors.

NEW BUSINESS

Board Member Vacancy

Joshua Ramos is retiring from elections effective November 15, 2019 and therefore, there will be a Board member vacancy. After discussion and a review of the Bylaws, Ruie Lavoie was directed to send out a call for nominations to all MAEO members. The Board will meet in closed session prior to the next session to select the replacement.

Mr. Ramos expressed in interest in continuing his membership with MAEO. It was noted that Mr. Ramos has been an active member of MAEO for approximately 30 years. A review Bylaws, specifically regulations regarding nonvoting membership was completed, and the Board held a brief discussion.

MOTION: In accordance with the requirements for nonvoting membership, Ruie Lavoie made a motion to waive the lifetime membership for Joshua Ramos.

SECOND: Alisha Alexander

ACTION: Favorable and unanimous, Motion carried.

Towson University – Training Program

Representatives from the University outlined a program they are offering.

OPEN FORUM

The floor was opened for comments and questions.

NEXT MEETING

The next meeting will be held on December 13, 2019 at the Anne Arundel County Board of Elections in Glen Burnie, Maryland. The Annual Holiday Social will be held directly after the meeting.
