

Dear Maryland Election Officials,



Dear Maryland Association of Elections Officials (MAEO),

Two common headlines dominate the news today: the COVID-19 pandemic and the 2020 elections. While Americans rightfully focus on the former by taking the necessary precautions to social distance and pay extra attention to personal hygiene, they rely almost entirely on their government leaders to make sure they can exercise their right to vote. That means the work at the local, state, and federal levels to administer elections, is more important than ever.

With so much at stake this year, voters deserve the opportunity to make their voices heard by voting for leaders they believe can deliver them brighter futures. Like election officials across the country, your dedicated efforts during the primary election season helped Maryland voters cast ballots safely and securely despite the rapidly changing public health conditions.

Now we face the steeper challenge of increased voter turnout and heavier public scrutiny for the general election. We luckily have the benefit of hindsight and the collective wisdom of the best practices across the country as we look forward to November. The U.S. Election Assistance Commission has worked to ensure that state and local officials have access to the information and resources to succeed. These include a series of documents that provide guidance for state, local, tribal, and territorial election officials on how to administer and secure election infrastructure in light of the COVID-19 epidemic, and the testimony of election officials from across the country about their experiences in meeting these challenges that they provided in bipartisan hearings the EAC held earlier this year.

Earlier in the spring, as part of the \$3.6 billion in stimulus funds that the U.S. Congress provided to states to address the pandemic, the EAC helped distribute \$400 million for states to safely hold elections. Still, we know your jurisdictions continue to see significant cost increases associated with running both the largest mail and absentee election they have ever had to run alongside in-person voting operations that protect against the dangers of COVID-19. On that note, we hope the EAC's initiative for National Poll Worker Recruitment Day on September 1 will help bring the additional support you need from civic-minded Marylanders. More information is available at helpamericavote.gov.

As we head into these final months before the election, please know our agency recognizes your dedicated service to the voters in Maryland. Thank you for your hard work in these unique times, and I appreciate you inviting me back to your conference this year.

U.S. Election Assistance Commission



COMMISSIONER THOMAS HICKS

Thomas Hicks was nominated by President Barack H. Obama and confirmed by unanimous consent of the United States Senate on December 16, 2014 to serve on the U.S. Election Assistance Commission (EAC). He has served as chairman of the commission for two terms.

Commissioner Hicks has focused his efforts on voter access. Under his leadership, the EAC developed a pocket-sized <u>voter card</u> that serves as a guide on voting rights for voters with disabilities. The card is provided in both Braille and large print. The EAC has worked with advocacy groups and election officials to distribute the card.

In addition, Mr. Hicks has addressed the difficulties overseas voters have when requesting and returning their ballots, such as dealing with foreign IP addresses and issues with timely ballot delivery. He worked with key states to set up a help desk. Now, overseas voters receive an email response directing them to the help desk to obtain their ballots.

He serves as the designated federal officer for the **Board of Advisors**.

Mr. Hicks is a frequent speaker at conferences in the United States and overseas on issues such as voter access and cybersecurity.

Prior to his appointment with EAC, Commissioner Hicks served as a senior elections counsel and minority elections counsel on the U.S. House of Representatives Committee on House Administration, a position he held from 2003 to 2014. In this role, Mr. Hicks was responsible for issues relating to campaign finance, election reform, contested elections and oversight of both the U.S. Election Assistance Commission and the Federal Election Commission. His primary responsibility was advising and providing guidance to the committee members and caucus on election issues. Mr. Hicks has talked with Americans in every state about their voting experiences. In addition, he has worked with state and local election officials across America to address critical election concerns.

Prior to joining the U.S. House of Representatives, Mr. Hicks served as a senior lobbyist and policy analyst from 2001 to 2003 for Common Cause, a nonpartisan, nonprofit organization that empowers citizens to make their voices heard in the political process and to hold their elected leaders accountable to the public interest. Mr. Hicks has enjoyed working with state and local election officials, civil rights organizations and all other stakeholders to improve the voting process.

Mr. Hicks served from 1993 to 2001 in the Clinton administration as a special assistant and legislative assistant in the Office of Congressional Relations for the Office of Personnel Management. He served as agency liaison to the United State Congress and the president's administration on matters regarding federal personnel policies and regulations.

Mr. Hicks received his J.D. from the Catholic University of America, Columbus School of Law and his B.A. in Government from Clark University (Worcester, MA). He also studied at the University of London (London, England) and law at the University of Adelaide (Adelaide, Australia).

BIOGRAPHY DELEGATE SHEREE L. SAMPLE-HUGHES



Delegate Sheree Sample-Hughes, elected to the Maryland General Assembly in 2014 representing Wicomico & Dorchester Counties (District 37A), is the first African American female elected from the Eastern Shore to serve in the Maryland House of Delegates. She is a member of the Health & Government Operations Committee, former treasurer for the Eastern Shore Delegation, and is a member of four House of Delegate caucuses: the Veteran's Caucus, the Waterman's Caucus, past president of the Women's Caucus, and financial secretary of the Legislative Black Caucus of Maryland. During the past few years, Sample-Hughes was appointed (2015) as the Eastern Regional Director with Women in Government, a national non-profit and non-partisan organization of state women legislators and in 2018 elected by her peers as Chair of Region III (Maryland & Delaware) for the National Black Caucus of State Legislators. Most recently, Sample-Hughes was appointed to serve as Speaker Pro Tempore by MD House of Delegates Speaker Adrienne Jones, both she and Jones making history in the state of Maryland.

A graduate from the following schools; Parkside High School in 1995, Delaware State University in 1999 with a Bachelor of Arts Degree in Public Relations, 2013 Academy of Excellence in Public Policy from the University of Maryland College Park and in 2014 obtained a Master's of Science in Management degree with a concentration in Public Administration from Wilmington University. Currently, enrolled at Catonsville Community College pursuing an associate degree in Mortuary Science. She currently works as an adjunct professor at Wor-Wic Community College.

Sample-Hughes firmly believes "Living A Life of Service" is the embodiment of who she is as she interfaces with families during their times of bereavement while serving as a Funeral Home Attendant with the Stewart Funeral Home by Holloway-Downey located in Salisbury, MD. In 2006 and in 2010, Sample-Hughes was elected to serve District 1 on the Wicomico County Council, once again making history as being the first African American female to serve. Delegate Sample-Hughes has been a champion on mental health, public safety, environment and education issues throughout her district. A recent notable accomplishment is that she was the recipient of the Tri County MLK Coalition, Inc. 2018 Rev. Dr. Martin Luther King, Jr. Achievement Award in recognition of humanitarian services to the community.

In addition, she is a member of the following organizations: Wicomico County Branch of the NAACP, Delta Sigma Omega Chapter Alpha Kappa Alpha Sorority Inc., the American Legion Auxiliary Unit #145 and Wesley Temple United Methodist Church. She is married to Desmond Hughes, they are the proud parents of Jordan and Noah. She has embraced a personal philosophy that inspires her every day "focus, follow and fulfill your dreams".

MAEO LEGISLATIVE COMMITTEE REPORT MAEO ANNUAL MEETING VIRTUAL MEETING AUGUST 25, 2020

The MAEO Legislative Committee ("the Committee") tracked about 100 election-related bills during the 2020 General Assembly session, and provided written input on a number of pieces of legislation. The session was cut short, adjourning on March 18, due to COVID-19, so few election bills were enacted. The governor let these bills become law without his signature.

HB 37 – Election Law – Absentee Voting – References in Public Communications and Prepaid Postage for Return of Ballots - Requiring the State Board of Elections and each local board of elections to refer to absentee ballots as "mail-in" ballots and absentee voting as "mail-in voting" in all communications; requiring the State Board and each local board to include in public communications a statement that "mail-in voting" is referred to as absentee voting in the Maryland Constitution, the Annotated Code of Maryland and the Code of Maryland Regulations; making provision for absentee ballots to include prepaid return postage.

HB 216 – Election Law – Campaign Material – Definition - Altering the definition of "campaign material" to include certain material that is an automated or prerecorded oral communication. Effective 1/1/2021

HB 465 – Election Law – Campaign Material - Disclosure of the Use of Bots - Requiring certain persons that use a bot to publish, distribute, or disseminate campaign material online to another person in the State for the purpose of influencing an election to disclose in a clear and conspicuous manner on the campaign material that the person is using a bot to publish, distribute, or disseminate the campaign material; authorizing the State Board of Elections to seek to remove a bot under certain circumstances.

SB 145 – Election Law – Absentee Voting – References in Public Communications and Prepaid Postage for Return of Ballots – same as HB 37.

SB 390 – Election Law - Candidate Defeated in Primary Election - Write-In Candidacy in General Election Prohibited - Prohibiting a candidate who is defeated for the nomination for a public office from filing a certificate of candidacy as a write-in candidate at the next succeeding general election as a candidate for any office. Effective 1/1/2021

SB 537 - General Assembly - Legislative Newsletters - Publication Expenses and Links to Social Media Accounts - Providing that publication expenses related to unofficial legislative newsletters may be paid by an authorized candidate campaign committee, rather than a campaign account of a campaign finance entity, of an incumbent under certain circumstances; providing that an official electronic legislative newsletter may include a link to a social media account only under certain circumstances.

MAEO Legislative Co-Chairs Stuart Harvey and Katherine Berry both submitted testimony on behalf of MAEO to both the Senate Education, Health and Environmental Affairs Committee ("EHEA") and the House Ways and Means Committee on various bills.

The Committee looks forward to continuing to work with the General Assembly members, SBE and other organizations during the 2021 session and beyond towards improving elections in Maryland.

The MAEO Personnel Committee is pleased to report it enjoyed a successful year in the time since the previous conference. In partnership with Shermaine Malcolm, Director, Maryland State Board of Elections (SBE) Personnel Services Division and Christine Lohr, SBE Human Resources Officer, the Committee guided the adoption of new election series job classification and updated position descriptions for state employees. The Committee would like to thank Mrs. Malcolm and Mrs. Lohr for their tireless efforts supporting the goals of the MAEO Personnel Committee. They were instrumental in SBE approving the reclassification of current state employees into the new election judge series and a 6% pay increase effective July 1, 2020.

The new election series position descriptions are based on the principles of Program Management and will allow the local Boards of Elections that operate under the State Personnel System to greater flexibility when hiring and reclassifying staff. Along with the new position descriptions, there are also more job titles, which will allow staff members greater opportunity to advance their careers in election administration. The new job titles also enjoy higher grades than the previous election series. This will allow employees to earn better salaries and aid the recruitment process when Local Boards seek to fill vacant Election positions.

While the Committee has accomplished many goals, there is still a great deal of work to be done. The Committee will provide information and support to local Boards who are not in the State Personnel System, but need to update and modernize their job descriptions and job titles. The Committee will also update the job specifications and grades for Election Directors and Election Deputy Directors I, II, and III, and seek their first salary increase in nearly 10 years.






