February 23, 2023 MINUTES

A meeting of the Maryland Association of Election Officials (MAEO) was held in person on the 23rd day of February 2023. Notice of the meeting and the agenda were properly provided. The meeting was held at the Baltimore County Board of Elections office.

CALL TO ORDER:

President David Garreis called the meeting to order at 10:05 am. A quorum was established with 9 of the 9 board members present. Introductions were made and roll call of those in attendance was recorded.

PRESIDENTS REPORT:

Mr. Garries welcomed everyone to the meeting and thanked Highstarr Copy and Printing for the breakfast and lunch they were providing for MAEO today.

MINUTES:

Ms. Goldman presented the minutes of the January 24th meeting for their approval. Ms. Kim Phillips motioned to accept the minutes as presented. It was seconded by Mr. Anthony Gutierrez. The motion carried.

TREASURER'S REPORT:

Ms. Danna Archie Williams presented her report. We are on track for the Conference budget this year. As of right now we have 319 members, and the number of memberships is rising. She is still waiting for 3 LBE's to give her their counties membership forms.

She reported that the educational funds are low and wants to talk to the Board about raising funds and suggests that the grants be put on hold this year due to the low balance. For example, this year 7 members went to iGO and the cost was 7×400 . We need to build in policy or business practices on the grant monies give out to individuals.

Ms. Chrissy Jones and Mr. David Garreis suggested if a grant is given then they should participate in fund raising for the committee.

Ms. Kimberly Phillips made a motion for a new business process. The motion was as follows:

- 1. Make sure every conference has a fund raiser for the educational fund.
- 2. Put funding on hold.
- 3. Application must be a committee active member.
- 4. Draw up guidelines.
- 5. Board be the final approval on grants.
- 6. Ms. Archie-Williams will work with Ms. Hatfield on the work process.

The motion was seconded by Ms. Tae Frere. Motion carried.

COMMITTEE REPORTS:

Audit–Ms. Gail Hatfield reported that it is too early for this report.

Legislative – Ms. Berry briefly went over some bills. She stated bills are moving fast. HB130 has crossed over. SB195 is on second reader today. (SB195 is the bill concerning making orphans court judges race a non-partisan race.

Mail-In Voting – Ms. Frere reported they met for a lesson learned. They submitted a lot of information to Jennfer and are working on cleaning up issues. They will meet again in March.

Newsletter – Ms. Jessica Norenbrock reported that they met this last Tuesday. Planning a pre-conference issue. Will reach out to LBE's for contact information.

Personnel – Ms. Lavoie and Ms. Perrone co-chair this committee. The election series will not change. However, they are open to help anyone with forms etc. that need to be filled out for personnel.

Standards- Ms. Dionne Church has nothing to report on currently but look forward to setting up a meeting soon.

State Regulations Review – Ms. Berry said they are meeting to clean up regulations.

Voter Outreach-The committee is trying to set up a meeting in March.

Website-Mr. Aslam reported that the website is up to date.

OLD BUSINESS:

Conference 2023:

Ms. Lavoie asked the membership to make reservations ASAP. If you do it on the online portal the hotel will take out one day. If you call up, they will not.

If you are going to pay by check the hotel needs the rooming sheet and payment by check mailed in prior to the conference. If you are paying by credit card the first person checking in will have to pay for all the attendees from that county. Each person will be asked for a credit card to be placed on record for incidentals.

This year Ms. Lavoie is happy to start the first book club will meet on Monday. She will let the membership know which book they will be discussing.

She listed the 2023 conference session for the Board. Mr. Garreis said to move forward with the agenda.

Ms. Lavoie also addressed the conference fee. With the rising cost of food etc., she feels that we need to raise the conference fee to \$250.00. In addition, guests must pay the full price. There is nowhere in Ocean City where you can eat 3 meals a day for 5 days for that cost. Mr. Barry Jackson made a motion to change the cost of the conference and agenda. Seconded by Ms. Kimberly Phillips. Motion carried.

Ms. Lavoie suggested that MAEO be administered the oath of office and to be ethical and should be done annually at the conference. Ms. Lavoie made the motion and Ms. Danna Archie-Williams seconded. All voted for it. Motion carried.

Mr. Gutierrez asked that the 60th anniversary of MAEO is coming up asked are we planning to do anything to commemorate it. Ms. Lavoie said we are now.

NEW BUSINESS:

Ms. Berry from the Legislative Committee suggested a Legislative event. It would be a type of meet and greet for the legislature. She has no idea of the cost of it but maybe we could partner with another organization.

"No Time to Fail" is a publication and movie from Rhode Island that we can view and discuss for a MAEO learning session in the future. Rhode Island is very interested in showing it to us. (From the website: Amidst an onslaught of attacks from a sitting President and the deadly threat of a global pandemic, local election administrators work around the clock to secure the vote for their community. Rhode Island's election teams take center stage in this unprecedented voting adventure.").

Ms. Lavoie made a motion to schedule it after the conference for a continuing education program for MAEO. Seconded by Ms. Archie-Williams. Motion carried. It was also suggested to invite the new LBE board members to it.

Mr. Andy Hightower and Mr. Shane Thompson from Hightower Copy and Print services introduced themselves.

ADJOURNMENT

There being no further business, on a motion made by Ms. Ruie Lavoie and second by Ms. Danna Archie-Williams, the meeting was adjourned at 11:30 am.
